WCA Ratings Tests are conducted under the rules and regulations set forth by the Weimaraner Club of America. Entries are limited to Weimaraners only. Spayed and neutered Weims may participate. Dogs with disqualifying faults may compete if spayed or neutered. All owners must be members of the Weimaraner Club of America.

Two tests will be offered during the day.

Test #1 and Test #2 will offer 2 different set-ups.

Water marks thrown by hand and wingers.**

- Land followed by water on both Test #1 and Test #2
- Actual running order will be posted on website
- Dogs may be entered in both tests by the deadline
- Dogs may be entered in any level at 1 or both tests
- No changes to level may be made on test day.

(i.e. If dog is entered in NRD Test #1 and again in Test #2, dog must remain at that level. However, if dog is entered in NRD Test #1 and RD Test #2 but does not pass NRD, dog must still run RD in Test #2. Test #1 may not be repeated unless entered previously.)

Test #2: Land and Water (As Above. Fees are duplicated for Test #2)

Birds: Quail for land tests; Duck for water tests

Bitches in season are not eligible to participate.

Refunds will be made for bitches that come in season after entries close.

Entries are limited to the number of dogs that can be run within daylight hours and will close when the limit is reached if this occurs prior to the entry deadline. Standby entries will be notified if space becomes available, or entry fees will be refunded. Only completed entries received with payment prior to closing will be drawn.

Directions:

From I-30 East in Garland, turn South onto Belt Line Road. At the 3rd traffic light (Barnes Bridge Road), turn left (East). Go about 150 feet, turn left into the 1st drive with recessed gate. Look for Williams and LSWC event signs. **PLEASE ALWAYS** make sure to latch gate securely behind you. Follow signs on path to test area (past barn), and park where indicated. Slow! Dogs and people!

From West: I-20W, Keep right at the fork to continue on TX-557 Spur W, follow signs for US-SOW/Dallas, take the exit toward Belt Line Rd., Merge onto US 80 Frontage Rd., Turn right onto N Belt Line Rd., Turn right onto Barnes Bridge Rd., Left at 1st driveway on left. Look for LSWC signs.

Exhibitors:

- *Please submit separate entry form for each dog entered*
- *No late entries/payment accepted. No refunds after entry deadline. Standby entries will be notified if space becomes available.*
- *Remember to bring water for you and your dogs! Pop-ups and chairs for you! There is limited shade.*
- *There will be no break for lunch. Please plan to bring your lunch and beverages. The club will have additional water and snacks on site.*
- *All attendees must wear BLAZE ORANGE.*

Entries qualifying for a Retrieving Rating are awarded a ribbon by the Lone Star Weimaraner Club, and will be recommended to the Weimaraner Club of America for approval and issuance of a certificate. Ratings are official when confirmed by the Weimaraner Club of America.
